PARISH HALL FLOORING UPDATE

As of January 25, 2026 the total flooring donations is \$17,827.35. The flooring bill to be paid is \$31,850.56. The amount owing is \$14,543.21. (A down payment of \$16,000 has been made) *Council has recommended, to be approved at the next Voters meeting, that \$9,000 be used from the Memorial Fund. Therefore, **\$5,023.21** is still needed.*
